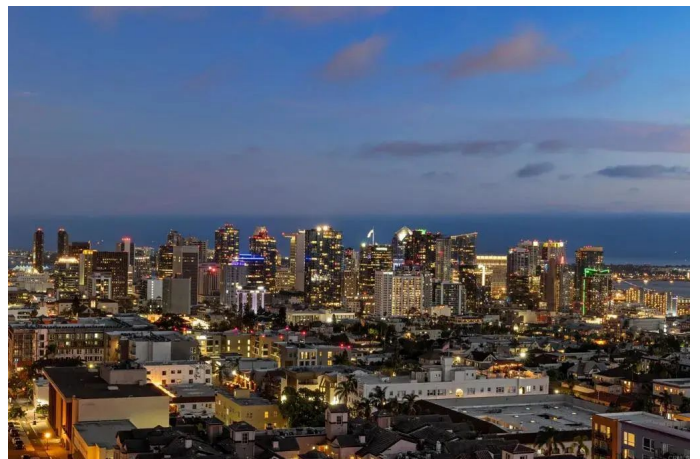
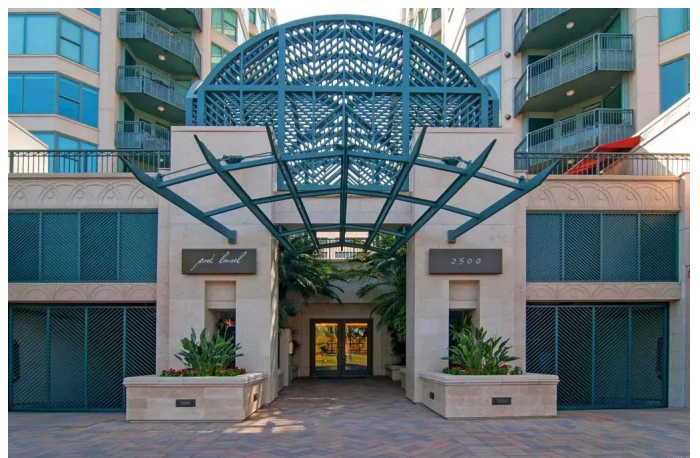

Residents enjoy Park Laurels 24-hour concierge front desk services, pool, spa, fitness center, and a premier location next to Balboa Park, with The Old Globe, museums, renowned restaurants, cafs, Little Italy, downtown, and the waterfront all within walking distance.
